



■ Studio City Casino Gross Gaming Revenue ■ SCIH Total Operating Revenue







Debt Maturity Profile as of March 31, 2025 (US\$ million)




Liquidity and Debt Positions as of March 31, 2025 (US\$ million)⁽¹⁾


